



Boarding Contract

The following training contract is between (Print Dog Owner Name) _____ (Hereinafter called "Owner") and West Wind Retrievers & Training (Hereinafter called "WWRT"). Owner listed above hereby agrees by contract to hire WWRT for the purpose of boarding. (Print Dog Name) _____ (Hereinafter called "Dog") will be boarded by WWRT bound with this contract.

Initial each section below:

- ___ Owner agrees to pay the rate for boarding of \$_____/day, in effect the date Dog arrives, through the final day of boarding. Dog will remain in boarding from _____ to _____.
- ___ Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for Dog during the time said dog is in the care of WWRT.
- ___ Owner agrees that the Dog shall not leave the WWRT until Owner pays all charges to the WWRT.
- ___ Owner agrees that the WWRT assumes NO ownership or guardianship and therefore No liability associated with animal.
- ___ Owner further agrees to be solely responsible for all acts of behavior, if it bites another Dog or people of said Dog while it is in the care of the WWRT, for boarding; therefore Owner will hold WWRT, it's representatives, and John C. Kello free and harmless from any and all claims, liabilities, damages, losses or expenses arising out of any injury to any persons or person's property by the Dog named in this contract, while in the care, custody & control of WWRT.
- ___ Owner specifically represents that he or she is the sole owner of the Dog, free and clear of all liens and encumbrances.
- ___ Owner specifically represents to WWRT that the Dog was not been exposed to rabies or distemper within a 30-day period prior to boarding.
- ___ The WWRT will grant a lien on the Dog for all unpaid charges, resulting from boarding Dog at the WWRT.
- ___ Owner hereby agrees that in the event the boarding charges are not paid when due in accordance with this contract, the WWRT may exercise its lien rights upon ten days written notice given by WWRT to Owner by certified mail, to address shown on contract.
- ___ If Dog becomes ill or if the state of the animals health otherwise requires professional attention, the WWRT, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by Owner.
- ___ All charges incurred by Owner shall be payable upon pick-up of Dog, or when billed by WWRT at the address listed on Contract. WWRT shall have, and is hereby granted, a lien on Dog for any and all unpaid charges resulting from boarding the pet at WWRT.
- ___ If Owner does not pick up Dog within 15 calendar days after Dog was scheduled to be picked up, Dog shall be deemed abandoned.
- ___ Owner grants WWRT and its representatives the right to take photographs of Owner and/or Dog in connection with above-identified purpose; agreeing that WWRT may use such photographs of Owner and/or Dog with or without my name and for any lawful purpose, including for such purposes as publicity, illustration, advertising, and Web content.
- ___ WWRT reserves the right to change your dogs type of boarding/care and/or to provide or decline additional services, if it is necessary to protect the health and well-being of your dog, other dogs or our staff. (Additional charges may apply.)
- ___ Current rates and services may change without notice. WWRT reserves the right to adjust its rates and fees for services. Hours are posted any other time please make an appointment (804) 922-7985 or (757) 353-1741
- ___ After hours pickups may have an additional charge.
- ___ Medication/Supplement charges may apply for the administration of medications.
- ___ Destruction of property (Kennel beds, crates or fencing) may incur additional charges.
- ___ By signing Contract and leaving the Dog with WWRT, Owner Certifies to the accuracy of all information given on back of Contract.
- ___ This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators and personal representatives' of Owner.
